- Round Two: The Project RFP was advertised a second time in the national Dodge Report Classified for two weeks and on the PCHA Procurement Website; and at least three regional firms were notified of the advertisement. Only one bidder submitted a Proposal (Hydro-Klean, LLC).
- 3. The second public bid opening was held at the PCHA Office on August 31, 2023, at 2:30pm CT.
- 4. The recommended apparent low bidders' Proposal was reviewed and found to be complete as necessary.
